CURRICULAR DEVELOPMENT

As Program Director, I have designed and redesigned the curriculum to meet ACGME requirements. Most recently, I rewrote the curriculum to comply with the milestone requirements. In so doing I rewrote all of our evaluation form to a format that meets the Reporting Milestones and have linked each milestone into a format that can be directly uploaded to the ACGME. Ambulatory Blocks have now been incorporated into the curriculum. During these Blocks residents now see their continuity patients during the afternoon. During the morning they complete the IHI curriculum, ABIM cost-effective curriculum, as well as the Yale ambulatory curriculum. They complete their individual QI projects. Simulation is also included during these blocks.

I wrote the curriculum and evaluation forms (Reporting Milestone based) for the Endocrinology Fellowship that started July 2013.

I developed a unique curriculum for a half-day course: Residents as Teachers.
